County Board of Commissioners of the County of Nemaha, State of Nebraska met on June 26, 2013, Commissioner's Chambers, Nemaha County Courthouse, Auburn NE for a regular scheduled meeting. Notice of meeting published in the Nemaha County Herald on June 20, 2013. The agenda was held open until one business day prior to the meeting for appearance before the board and items for approval by the Board of Commissioners. <u>Meeting Called to Order</u> – Chairman Hutton called the meeting to order at 8:00 a.m. Present for the meeting: Commissioner District 1 Bob Hutton, Commissioner District 2 Dennis Wittmann, Commissioner District 3 Marvin Bohling and County Clerk Joyce Oakley.

8:15 a.m. Public Hearing – Resolution 2013-30 -Amending the FY 2012-2013 budget for Drug Coalition – Public hearing for amending the FY 2012-2013 budget for Drug Coalition was opened by Commissioner Wittmann at 8: 20 a.m. Notice of public hearing was advertised in the Nemaha County Herald on June 13, 2013 and June 20, 2013. The following were present at the public hearing: no one. Commissioner Wittmann closed the public hearing at 8:23 a.m.

Agreement for Emergency Protective Custody Services with Region V Systems Motion by Bohling seconded by Wittmann to approve the agreement for Emergency Protective Custody Services with Region V Systems in the amount of \$124.00 per day for the period July 1, 2013 through June 30, 2014. Roll call vote: Wittmann, aye; Bohling, aye; Hutton, aye.
- 6. 90 day Probation Period for Mike Sullwold ends July 8, 2013 Motion by Bohling, seconded by Wittmann to approve the end of probation period for Mike Sullwold on July 8, 2013 and to raise Sullwold's pay rate to the maximum rate on July 8, 2013. - 7. Authorize Lottmann to purchase/replace radios for sheriff's cruisers (state bids) Motion by Hutton seconded by Bohling to authorize Nemaha County Sheriff to purchase, through the state bidding, and replace 10 radios for the sheriff's cruisers and 1 base radio for the Nemaha County Jail in the amount of \$57,336.75 from Motorola Solutions, Inc. Roll call vote: Bohling, aye; Hutton, aye; Wittmann, aye.
- 8. Authorize Lottman to enter into an Interlocal Agreement for Cellebrite Investigative Equipment & Maintenance between Nebr City Police Dept/Otoe County Attorney Office/Otoe County Sheriff's Office/Fremont County Sheriff's office/Nemaha County Sheriff's Office Motion by Bohling seconded by Wittmann to authorize Nemaha County Sheriff's Brent Lottman to enter into an Interlocal Agreement with Nebr. City Police Dept./Otoe County Attorney's Office/Otoe County Sheriff's Dept/Fremont County Sheriff's Office for the purchase of a UFED Touch Ultimate from Cellebrite USA, Inc. and related annual maintenance. The interlocal agreement states the Nebr City Police Dept/Otoe County Attorney Office/Otoe County Sheriff's Office/Fremont County Sheriff's office/Nemaha County Sheriff's Office will jointly split the expense of \$9,334.00, for the UFED Touch Ultimate, with Otoe County ordering the equipment and the each political subdivisions reimbursing Otoe County \$1,866.80. The annual maintenance cost of \$2,998.99 will also be split between the 5 public entities





with each subdivision reimbursing Otoe County their cost of \$599.80. Roll call vote: Wittmann, aye; Hutton, aye; Bohling, aye.
