Notice of meeting was published weekly in the Nemaha County Herald. The agenda for the meeting was kept continually current and available for public inspection at the office of the Nemaha County Clerk during normal business hours and also on the Nemaha County website. The agenda was held open until one business day prior to the meeting for appearance before the board and items for approval by the Board of Commissioners. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

<u>Meeting Called to Order</u> – Chairman Bohling called the meeting to order at 8:02 a.m. Present for the meeting: Commissioner District 1 Bob Hutton, Commissioner District 2 Bryan Mellage, Commissioner District 3 Marvin





Bohling and County Clerk Joyce Oakley. Chairman Bohling led the Pledge of Allegiance and noted the posting of the Open Meeting Poster and the availability of the Open Meeting Handouts to the public.

Bohling will get back with more information if there will be a cost to the county and if money is going to be collected for drop offs)

8:45 a.m. Angelo Ligouri, Attorney for City of Auburn regarding tax exempt status on 2 properties recently acquired by the City of Auburn – Assessor Mallory Lempka and City of Auburn Attorney, Angelo Ligouri presented a letter of request to the Board of Commissioners to relieve 2016 back taxes, interest and penalty on parcel 640006191, 1211 14th Street, Howe, Nixon & Wilsons Addition Block 11 Lot 4. Ligouri indicated the City of Auburn received this property on nuisance abandonment case through District Court. 2016 taxes were not due or delinquent at the time the City of Auburn paid all the back taxes on this property, therefore the 2016 taxes were not paid and the city did not know they were owed until they received a notice from the Nemaha County Treasurer the taxes were delinquent. Motion by Bohling, seconded by Hutton to direct County Assessor Lempka to prepare and present a tax list correction for the approval at the February 7, 2018 Board of Equalization meeting.
