



Registering to Vote



How can I register to vote in Nemaha County, NE?

You can register to vote online at <https://www.nebraska.gov/apps-sos-voter-registration/>. You can register by mail, the application is on our website at www.nemahacounty.ne.gov. You may also register in person at the Nemaha County Clerk's Office, 1824 N St, Ste 201 Auburn, NE 68305, during normal business hours.

I am 17 years of age, am I able to vote in the Primary Election?

If you are going to be 18 years of age on or before November 3, 2020 you are eligible to register to vote and vote in the Primary Election.

What is the deadline for registering to vote for the 2020 Primary Election?

Voter registration closes on Friday, May 1, 2020 at 6:00 p.m.

Can I register to vote online?

You can register to vote online at <https://www.nebraska.gov/apps-sos-voter-registration/> by April 27, 2020.

Can I register to vote through the mail?

Voter registrations sent by mail must be post marked by Friday, April 28, 2020, for a registrant to be eligible to vote in the Primary Election. You must also submit a copy of your photo ID or other acceptable identification listed on the application.

What if I have changed my name or moved since the last time I voted?

You are required to change your name or address by the Friday, May 1, 2020 deadline.

What happens if I don't change my name or address?

Can I still vote?

If the deadline has passed for making the changes, you can still vote, however you will need to vote a Provisional Ballot at your new polling site.

It has been several years since I have voted, is my voter registration still active?

Unless you have moved or changed your name, your voter registration is still active and you do not need to do anything for the primary election. If you would like to check your party affiliation or find out where to vote, this information can be found at the Secretary of State's website at www.sos.ne.gov.

What if I don't know my party affiliation?

Can I change my party affiliation for the Primary Election?

You will need to re-register to vote by the deadline of 6:00 p.m. on Friday, May 1, 2020.

How do I apply for an Early Voting Ballot?

You can make application for an early voting ballot in person, by personal agent, mail, or fax at the Nemaha County Clerk's Office. Applications for early voting can be found on the Nemaha County website: www.nemahacounty.ne.gov, and they will also be published in the Nemaha County Herald on April 9, April 16, and April 23, 2020.

When is the last day to make application for an Early Voting Ballot?

May 1, 2020- The last day an Early Voting Ballot can be mailed to a specific address for the Primary Election.

May 11, 2020 - The last day to cast an Early Voting Ballot in person at the County Clerk's Office.

May 12, 2020 - 7:00 p.m., The deadline an agent may pick up an Early Voting Ballot for a voter.

When must Early Voting Ballots be returned to the Election Office?

All Early Voting Ballots, whether personally delivered, delivered by agent, or delivered by mail or other carrier, must arrive by the closing of the polls on Election Day, May 12, 2020 (8:00 p.m.).
