County Board of Commissioners of the County of Nemaha, State of Nebraska met on Wednesday, September 11, 2019, Commissioner's Chambers, Nemaha County Courthouse, Auburn NE for a special budget meeting. Notice of meeting was published in the Nemaha County Herald on September 5, 2019. The agenda for the meeting was kept continually current and available for public inspection at the office of the Nemaha County Clerk during normal business hours and also on the Nemaha County website. The agenda was held open until one business day prior to the meeting for appearance before the board and items for approval by the Board of Commissioners. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

Chairman Mellage called the meeting to order at 8:00 a.m. with the Pledge of Allegiance. Present for the Meeting: Mike Hall, Commissioner District 1; Bryan Mellage, Commissioner District 2; Larry Holtzman, Commissioner District 3 and County Clerk Joyce Oakley. Chairman Mellage noted the posting of the Open Meeting Laws posted on the bulletin board.

Approval of Agenda – Motion by Holtzman, seconded by Hall to approve the agenda as presented: Roll call vote: Holtzman, aye; Mellage, aye; Hall, aye.

Chairman Mellage opened the public hearing at 8:00 a.m. for adopting the FY 2019-2020 Nemaha County budget. No one was present. Chairman closed the public hearing at 8:15 a.m.

Chairman Mellage opened the public hearing at 8:15 a.m. for setting the final tax request for FY 2019-2020 @ \$.340413. Present: no one. Chairman Mellage closed the public hearing at 8:32 a.m.

Motion by Hall, seconded by Holtzman to adopt Resolution 2019-33 approving the allowance increase of the base limitation percent of 2.5% plus the additional 1% for the FY 2019-2020 budget. Roll call vote: Mellage, aye; Holtzman, aye; Hall, aye.

Motion by Holtzman, seconded by Hall to adopt Resolution 2019-34 adopting the FY 2019-2020 budget. Roll call vote: Holtzman, aye; Hall, aye; Mellage, aye.

Motion by Hall, seconded by Holtzman to adopt Resolution 2019-35 setting the FY 2019-2020 tax rate \$.340413. Roll call vote: Mellage, aye; Hall, aye; Holtzman, aye.

With no further business to come before the Board of Commissioners, motion by Holtzman, seconded by Hall to adjourn at 8:37 a.m. Roll call vote: Hall, aye; Mellage, aye; Holtzman, aye.
